## WEDNESDAY, MAY 20:

- Entry Deadline  
- \$2,995 per entry
- Mini Tour Advertorial and Dream Home Entry Deadline

## THURSDAY, JUNE 18:

- First proofs mailed

## THURSDAY, JUNE 25:

- First proofs must be returned to BATC
- Last date to withdraw (entry fee less \$100 returned).  
Written notification must be received by the BATC office on or before this date
- Deadline to substitute or move entry to another city

## THURSDAY, JULY 2:

- Deadline for professional or CAD illustrations, or photos provided by builder

## FRIDAY, JULY 10:

- Advertising sales close

## TUESDAY, JULY 14:

- Final proofs mailed

## FRIDAY, JULY 17:

- Ad materials due

## TUESDAY, JULY 21:

- Final proofs must be returned to BATC
- Deadline to banner "Not Available for Showing"
- Deadline to substitute or move entry within the same city
- Deadline to change price

# ENTRY CHECKLIST

## REQUIRED:

- ENTRY FORM (2 OPTIONS)**
  1. Home/Model Entry Form, or
  2. Development Entry Form

You may enter either a home or a new development. See regulations on page seven for new dev's.

One original form per entry. Call 651-697-7568 for additional forms.
- ENTRY FEE** \$2,995 per entry (Check payable to BATC) Includes sign escrow. You may include all entries on one check.
- HUDSON'S, KING'S OR SOME SORT OF MAP PHOTOCOPY FOR NEW ENTRIES ONLY.** *If your entry address is an exact repeat, we don't need a map.*
- SIGNED PARTICIPATION AGREEMENT** One per builder
- CERTIFICATE OF LIABILITY INSURANCE** showing coverage through 10/4/09
- PHOTOCOPY OF CURRENT MN RESIDENTIAL CONTRACTOR LICENSE** One per builder.  
**Exception:** BATC Class D/E builders. The Class D/E Builder form must be completed if you are not required by the State of MN to have a residential contractor license.
- HOME ART**
  1. Blueprint front elevation  
**OR**
  2. High-resolution electronic file of professional drawing or CAD illustration  
**OR**
  3. New Color Guidebook  
**Option** - Submit a color photo or illustration for \$300. (*see order form enclosed*)
